THIS LICENSE AGREEMENT IS HEREBY ACCEPTED BY STUDENT HOUSING AS LICENSOR (Bed space subject to availability)

TERMS AND CONDITIONS OF OCCUPANCY

- LICENSE AGREEMENT:** Licensor grants permission to Licensee to participate in a meal plan and use the housing facilities in exchange for: (i) Licensee's timely payment of the applicable on-campus living/meal plan fees, and (ii) Licensee's timely compliance with all provisions of this Agreement. This Agreement is not intended to create any interest in real property, taxable, possessory or otherwise. This Agreement may not be changed or amended without the express written consent of the Licensor. Time is of the essence as to all of Licensee's obligations hereunder.
- COVENANTS OF LICENSOR:** Licensor agrees that it will provide bed space and furnishings on an "as available" basis. Licensor reserves the right in its sole discretion to re-assign Licensee to another bed space or room upon forty-eight (48) hours advance notice to Licensee.
- COVENANTS OF LICENSEE:** Licensee agrees that he/she: (i) will comply with all terms and conditions of this Agreement, (ii) is enrolled at California State University, Fresno or Fresno City College, in a minimum of six (6) units, (although upon a hardship showing and at the sole discretion of Fresno State Student Housing, this requirement may be waived on a case by case basis); (iii) will maintain satisfactory health and accident insurance coverage of \$2,000 in hospital benefits, \$150 in medical benefits, \$350 in surgical benefits, and \$50 in emergency outpatient benefits per accident or sickness; (iv) agrees that Licensor is not responsible for lost, damaged or stolen property in or on the premises, including the parking areas and holds harmless Licensor from any such losses; (v) accepts whatever bed space is assigned/reassigned; (vi) will refrain from subletting, transferring or assigning any rights/obligations hereunder without the express written consent of Licensor; (vii) will timely and fully pay all room, board and other fees and charges arising from this Agreement; (viii) will act reasonably, lawfully and follow all published and/or posted notices regarding personal conduct; (ix) will follow established procedures as to guests/visitors and take responsibility for the conduct of such guests/visitors; (x) allow Licensor or its designee reasonable entry into any portion of the housing facilities, for purposes of health and safety inspections, to investigate suspected violations of Fresno State Student Housing policies, or otherwise; (xi) will vacate the housing facilities immediately upon the earlier of expiration or revocation of the license granted hereunder; (xii) refrain from altering, disturbing or damaging the housing facilities, furnishings, common areas and surrounding environment; (xiii) will pay, individually or in combination with other Licensees a reasonable charge for any such damage, and (xiv) indemnify, defend and save and hold harmless the Licensor, the State of California, Trustees of the California State University, California State University, Fresno and the California State University, Fresno Association, Inc. and all of said entities' employees, agents, representatives, boards, committees, predecessors and successors, as to any and all injuries, damages and/or claims arising out of or in any way connected with this Agreement, other than those solely caused by the intentional or negligent acts of the Licensor. A failure by LICENSEE to satisfy any covenant shall not excuse LICENSEE from the obligations contained in this Agreement.
- REVOCAION BY LICENSOR:** Licensor may revoke this Agreement upon Licensee's breach or violation of any term or provision herein, or upon any unforeseen condition which impacts the availability of housing facilities. Notice of such revocation shall be provided to Licensee at least forty-eight (48) hours in advance of such revocation. Upon any revocation or premature termination of this license, Licensee shall remain responsible for payment of all financial obligations incurred hereunder absent the express written consent of Licensor.
- TERMINATION BY LICENSEE:** Licensee may cancel this Agreement for any reason upon Licensee's submission of a signed, certified form of cancellation showing disenrollment from the University and Licensee's payment of a \$50 processing fee. However, if such cancellation request is received by Licensor after May 31, 2021 (for Fall, 2021) or October 31, 2021 (for Spring, 2022) but before July 19, 2021 (for Fall, 2021) or December 17, 2021 (for Spring, 2022), Licensee shall forfeit Licensee's \$150 security deposit. If such cancellation request is received by Licensor after July 20, 2021 (for Fall, 2021) or December 18, 2021 (for Spring, 2022), in addition to the foregoing forfeiture of Licensee's \$150 security deposit, Licensee will also be required to pay an additional assessment of up to \$25/day for each day that notice was not given prior to the beginning of the academic term (such assessment not to exceed \$750). In the absence of presenting a certified cancellation form from the University and thereby canceling this Agreement in the manner specified above, this Agreement may otherwise be canceled only upon: (i) Licensee's submission of Petition to Cancel/Vacate stating facts sufficient to support such relief as determined by Licensor in its sole discretion; and (ii) Forfeiture of Licensee's \$150 security deposit, and at the sole discretion of Licensor, an amount which shall not be less than one month's worth of all payments due under this Agreement, nor more than the sum of all unpaid amounts due and to become due hereunder through the remainder of the term hereof. Failure of a Licensee to appear, register and take possession of Licensee's room assignment by 11:00 p.m. on the Tuesday (new Fall) or on the Wednesday (new Spring) immediately preceding the beginning of the academic term which coincides with the term of this Agreement shall constitute a default of this Agreement, which shall subject Licensee to the processing fee, forfeiture of security deposit, and additional daily assessments referenced above and all other financial obligations due hereunder through the remainder of the term hereof, unless Licensee's obligations under this Agreement are assumed by a new licensee on the waiting list, in which case Licensee shall only be responsible for the \$750 No Show assessment, forfeiture of security deposit, the \$50 non-refundable application fee and the \$50 processing fee. If Licensee is notified that he/she is on "waiting list" status for a bed space, only the provisions of this section 5 and section 10 shall apply to Licensee. Once Licensee is notified of the guaranteed availability of bed space, all provisions of this Agreement shall apply to Licensee.
- SECURITY DEPOSIT:** A non-interest bearing, non-segregated, refundable security deposit against damage/breach in the amount of \$150 must be paid by all Licensees. The security deposit must accompany this Agreement in the form of either: an initial payment under a payment plan (i.e., security deposit comprises a portion of such initial payment) or a separate security deposit payment in the sum of \$150. Any remaining principal thereof is to be applied against any obligation(s) owed hereunder including, but not limited to past due license fees and meal fees, damages of any sort, cleaning fees and costs, etc. The security deposit funds of returning residents will be maintained on account absent instructions otherwise from the party entitled to such funds.
- LATE FEES:** Payments not received within 5 calendar days of the due date will be charged a \$25 late fee.
- NOTICES:** Any notice provided by Licensee to Licensor shall be sent via mail to the Director of Student Housing, 5152 N. Barton Ave. M/S RH82, Fresno, CA 93740-8013. Notices provided by Licensor to Licensee may be delivered in person, or sent by mail at any address provided by Licensee to Licensor.
- FINANCIAL AID PAYMENT AND CONSENT TO ACCESS TO FINANCIAL AND OTHER RECORDS:** If Licensee indicates in section VII (Payment Plan Information) that he/she is making payments through financial aid automatic deduction, Licensee hereby voluntarily authorizes and directs the University Financial Aid Office to pay Licensor against any debt obligation of Licensee arising out of this Agreement, by deducting such payments from Licensee's student financial aid monies and assigning such payments directly to Licensor. Additionally, Licensee, to the fullest extent possible, consents to and authorizes Licensor to have access to the following records maintained by the University: Licensee's financial aid records, student disciplinary records, as well as academic records including but not limited to enrollment status, class schedules, etc.

Financial Aid Payment Plan Only

The purpose of this agreement is to assist students who have applied for financial aid and/or a scholarship disbursed through the Fresno State Accounting Services Office by providing a payment plan option that delays the first payment(s) due date to September 5th (2021-2022 residents) or January 15th (New Spring 2022 residents) and is subject to the following conditions:

1. Applicants are required to submit the Payment Plan Agreement by July 15th (Fall/Spring) or December 1st (Spring only) to facilitate automatic deduction from your award.

Read and initial each of the paragraphs below to indicate that you have read and understand the terms of the agreement request.

- I understand that the room and meal plan financial obligation for the room type assigned and meal plan selected is my responsibility as stated in the Student Housing and Meal Plan License Agreement, whether or not the fees are covered by Financial Aid or scholarship. I may pay the full room and meal plan amount due by combining award amount and personal funds, if needed.
- I understand that it is my responsibility to immediately contact Student Housing's Accounting Office in the event of any changes in my financial aid award, enrollment status, or any relevant development regarding my ability to make payment(s). This does not relieve me of my financial obligation.
- I understand that any financial aid disbursed through the Fresno State Accounting Services Office will be applied first to my university registration and any other outstanding university debts. Any additional monies remaining will be disbursed as follows:
 - a. If I checked the Financial Aid Payment Plan on the Student Housing and Meal Plan License Agreement, and submitted my financial aid paperwork before July 15th (Fall) or December 1st (Spring), the Fresno State Accounting Services Office will send the balance of the financial aid award to Fresno State Student Housing to apply against my room and meal plan fee. It is my responsibility to review the financial aid disbursement information to verify that a deduction for housing is shown and to pay Fresno State Student Housing directly from my financial aid award if a deduction has not been made. Fresno State Student Housing will refund monies to me only if the amount received exceeds the room and meal plan fee.
 - b. If paperwork is delayed past July 17th for Fall (December 1st for Spring) and/or Fresno State Account Services has not posted Financial Aid amounts on my Student Account, prior to the first disbursement or funds are unavailable to come directly to Fresno State Student Housing (Pell, etc.), it is my responsibility to pay Fresno State Student Housing directly.
- I understand that all room and meal plan payments on Fresno State Student Housing's Financial Aid Payment Plan are due as follows:
First payment – September 5th (2021-2022 resident) or January 15th (New Spring 2022 resident). All remaining payments are due on the 5th of each month October-May (2021-2022 residents) or February-May (New Spring 2022 residents).
- I understand that it is my responsibility to setup my Vibe Card through BankMobile. I can be awarded my financial aid one of the following ways:
deposited to my BankMobile Vibe Card, deposited to my personal bank account, or personal check via mail.
- I understand that this agreement serves as an amendment to my 2021-2022 Student Housing and Meal Plan License Agreement; all other terms and conditions of the license agreement are binding. I further understand and acknowledge that a breach of this agreement will be considered a breach of my 2021-2022 Student Housing and Meal Plan License Agreement.

Financial Responsibility 2021-2022

Fresno State Student Housing is open to all Fresno State students; however, there are financial responsibilities that must be met if you apply for and are assigned a bed. Several aspects of the license agreement, as well as related Student Housing procedures, are discussed below. Please review the following:

1. The license agreement is binding for the **entire** academic year or for only the Spring semester.
2. You will be released from the license agreement only if you meet one of the following eligibility requirements (See full Cancellation Policy in the terms & conditions section on the back of your license agreement):
 - a. Cancel your license agreement with required form via certified mail by:
 - i. May 31st (2021-2022) or October 31st (New Spring 2022) \$50 cancellation fee assessed
 - ii. June 1st to July 19th (2021-2022) or November 1st to December 17th (New Spring 2022) \$150 assessed
 - iii. July 20th to August 18th (2021-2022) or December 18th to January 16th (New Spring 2022) \$150 fee and additional \$25 per day fee assessed
 - b. Petition to Cancel the Student Housing and Meal Plan License Agreement with \$50 processing fee between August 19th, 2021 - May 20th, 2022. Petition is subject to approval and fees. You must also meet one of the following requirements:
 - i. Complete withdrawal from the university
 - ii. Graduation from the university
 - iii. Join the military and are required to report to duty
 - iv. Participating in an approved exchange program and you submit a Petition to Cancel your license agreement by November 1st and your name is submitted to Student Housing by the program prior to the beginning of the Spring semester.
3. This agreement involves specific sums of monies due on specific dates. **Review your financial situation carefully.** If you are unable to make these payments as scheduled in the Financial Information sheet, do not sign the license agreement or submit an on-campus living application packet. A different living situation may be better suited to your budget.
4. Your room and meal plan charge is assessed as follows: room type **assigned** and meal plan **selected**.
5. Payments must be received in the Student Housing Accounting Office **on or before** the due date. Please plan carefully as there is a \$25 late fee charged for all payments received after the 5-day grace period. If you have a designated payor, all payments must still be received as scheduled.
6. If you are a Fresno State Financial Aid applicant or have been awarded an Athletic Scholarship or Smittcamp Honors College Scholarship the monies will be disbursed through the Fresno State Accounting Services Office, it is important to note that the university priority scholarship deadline was November 30th, 2020 and the Federal Application for Student Aid (FAFSA) priority deadline is March 1st, 2021.

In addition, if you submitted the FAFSA or scholarship application, you are encouraged to check the Financial Aid Payment Plan with Automatic Deduction on Student Housing's "Student Housing and Meal Plan License Agreement" in order to facilitate your room and meal plan payments.
7. If you will be awarded monies disbursed through the Fresno State Accounting Services Office and selected the Financial Aid Payment Plan on the "Student Housing and Meal Plan License Agreement," you **must** initial Student Housing's Financial Aid Payment Plan Section on the reverse side.
 - a. You are encouraged to submit your completed Payment Plan Agreement by July 15th or December 1st (Spring only), to facilitate the automatic deduction.

Note: Student Housing will continue to accept agreements after July 15th or December 1st (Spring); however, an automatic deduction may not occur as the University's Accounting Office requires requests for deductions prior to their financial aid disbursement dates.
 - b. For your best opportunity to receive housing, you are strongly encouraged to submit the completed on-campus living application packet early as bed space is subject to availability.

The medical services available weekdays from the Student Health and Counseling Center are included in your university fees and do not include off-campus medical care (i.e., emergency room, weekend and evening services). Because of the extreme personal expense of most medical services available off-campus, residents must carry health and accident insurance through a personal, federal, state, or parent group plan.
